## **Call for Nominations**

The Volleyball Alberta Awards and History Committee is currently gathering nominations to recognize outstanding achievements in Volleyball Alberta. The awards are presented in the following 5 categories: **Athlete**, **Team**, **Coach**, **Official and Builder**.

## How to submit a nomination:

The award candidate must be nominated by a third party and cannot nominate him/herself.

**Step 1**: Carefully review the award categories and determine which category is most appropriate (selection criteria attached) **Step 2:** Prepare and collect

1) At least one cover letter and one letter of support for the nominee which should include comments on how the nominee has made a defining contribution to Volleyball in Alberta and the nominee's demonstration of exemplary values and personal characteristics. In the cover letter, the nominator needs to state the relationship and how long they have known this person, under what conditions, etc.

2) A listing of all the relevant information (chronological list of accomplishments, records, statistics, CV, etc.) about the nominee. **Step 3:** <u>Complete the Nomination form on our website</u>

Step 4: Include a high quality, colour photograph of the nominee

**Step 5:** Ensure you have included all the items in Step 2, 3 and 4, above. Your nomination will not be processed without this information. **Step 6:** Submit your nomination package using the <u>online nomination form link</u> or by email to: <u>info@volleyballalberta.ca</u>

# **The Selection Process:**

- 1) Nomination packages must be received by April 1st. The Volleyball Alberta annual awards banquet is held in June.
- 2) Each nomination is eligible for three (3) consecutive years. If at the end of (3) consecutive years of eligibility, a nomination has not been selected for induction, the nomination must sit inactive for a period of one (1) year after which the nomination can be resubmitted.
- 3) All nominations will be considered at an initial Awards & History sub-committee meeting in April. Depending on the outcome of that process, further information on the nomination may be required. The final selection process will take place in the middle of April and the names will be released to media by May.
- 4) The committee will make the following remarks on each nomination: <u>Accepted</u>: Nomination will be forwarded to the Executive Committee for final approval. Following board approval, induction letter, invitation to the Awards Banquet as well as interview for biography will be initiated. <u>Complete with reservations</u>: Consider nomination for 3 years. Follow-up may be required to ensure proper induction category, or other reasons. <u>Incomplete</u>: Nominator needs to re-submit the nomination with more information. Declined.

**Volleyball Alberta Hall of Fame Selection Criteria** 

### 1. ATHLETE

Must have participated in Volleyball Alberta programs for a minimum of two years (club and/or provincial team). Accomplishments to be considered include:

- i. Canadian National Championships at all levels.
- ii. Canada Games participation and success.
- iii. CCAA/CIS All-Canadian and/or Player of the Year Status.

#### 2. TEAM

Team must be based in Alberta during the time of the accomplishment(s). Team must have competed in a league or system that is recognized by Volleyball Alberta.

Accomplishments to be considered:

i. Exceptional single seasons

(ex: undefeated championship teams).

ii. Consecutive championship teams.

### 3. COACH

Must have coached a minimum of five years in the Province of Alberta and in a league or system that is recognized by Volleyball Alberta.

Accomplishments to be considered include:

- i. Team success.
- ii. Individual athlete development and future success.
- iii. Coaching awards and recognition received.

- iii. Exceptional unbeaten streaks.
- iv. Any other exceptional accomplishments.

iv. National Team participation and success.

v. World Championship and/or Olympic participation.

- iv. Integrity and leadership.
- v. Commitment to the development of athletes and the sport of volleyball.

## 4. OFFICIAL

Must have officiated a minimum of five years in the Province of Alberta and in a league or system that is recognized by Volleyball Alberta.

Accomplishments to be considered include:

- i. Commitment to the sport of volleyball as demonstrated by years of service and activity.
- ii. Assignment to major championships and events.
- iii. Level of certification attained.

#### 5. BUILDER

Must have served in a volunteer capacity in the Province of Alberta for a minimum of five years.

Accomplishments to be considered include:

- i. Commitment to the sport of volleyball as demonstrated by years of service and activity.
- ii. Extraordinary contributions to the development of volleyball programs or events in Alberta.

It is the responsibility of the nominator to include all relevant information to support the nomination such as; letter of support, records, statistics, accomplishments, etc. in order to verify the merits of the candidate.
